- Blank pistols will be fired on all pointed birds except Puppy Stakes.
- The use of AKC Approved Tracking Collar will be permitted.
- It is mandatory that Judges, gunners, handlers of the working dogs and Marshals wear a blaze orange outer garment (vest or jacket minimum) in any Call Backs.
- Water is available on grounds for people, dogs, and horses.

*Outside birds may **NOT** be brought onto the grounds.*
